SWINDON SPITFIRES FC 28TH ANNUAL 6-A-SIDE TOURNAMENT 20TH and 21ST June 2009

Dear Secretary or Manager,

On behalf of Swindon Spitfires FC may I extend an invitation to your club/team to participate in our annual tournament over the weekend of **Saturday 20th and Sunday 21st June 2009**, at Ridgeway Leisure Centre, Wroughton, Swindon.

This is one of the few tournaments available to **girls and ladies teams only**. Last year we had over **100 teams** entering from **ten counties** and a number of age groups were over subscribed. Demand is likely to be high again this year so to avoid disappointment please get your entries in as early as possible, places will be allocated on a first come, first served basis.

We will be running competitions for the following age groups (depending on demand):

U8/9 *, U10, U11, U12, U13, U14, U15, U16, and Open Age.

* - In accordance with FA regulations the U8/9s will be on a festival basis with all players receiving medals.

The **entry fee** per team is **£15 for U8/9s, £25 for U10, U11, U12, U14, U15, U16 and £28 for Open Age.**

All players must compete in the age band for which they were eligible for during the 2008-9 season, the qualifying date being midnight on 31st August 2008. Open Age players must be over 16 as of midnight on 20th June 2009. Players may not play for more than one team on the same day and maximum squad size is eight players per team.

There will be a BBQ and refreshment tent available, along with other attractions.

Please complete and return the attached form to me specifying all required details - you must include your FA affiliation details. **Closing date for entries is 20th May 2009**; please make cheques payable to "Swindon Spitfires".

Please note that entry fees are non-refundable unless the competition is cancelled due to circumstances beyond our control. Should this happen fees will be refunded less a proportion of the costs incurred by Swindon Spitfires and their appointed representatives in the preparation of the event.

Entries will be acknowledged upon receipt by e-mail. Final entry confirmation will be sent by post, together with competition rules and directions etc, approximately two weeks before the tournament weekend. Swindon Spitfires reserve the right to refuse an entry if they so wish.

If you are no longer a Manager or Club Secretary could you please pass this information on to the correct contact, and please feel free to distribute to any other teams/clubs that you think may be interested.
